

Entry Requirements

A Special Degree with a First Class or Second Class (Upper Division) in any Business or Management related discipline (including Commerce, Economics or Public Administration) from a recognized University

OR

A Special Degree in any Business or Management related discipline (including Commerce, Economics or Public Administration) from a recognized University, and a minimum of one (01) year post qualifying work experience in managerial capacity

OR

A Degree with a First Class or Second Class (Upper Division) in any Business or Management related discipline (including Commerce, Economics or Public Administration) from a recognized University, and a minimum of one (01) year post qualifying work experience in managerial capacity

OR

A Degree in any discipline from a recognized University, and a minimum of two (02) years post qualifying work experience in managerial capacity

OR

A Degree in any discipline and at least a Postgraduate Diploma in any Business or Management related discipline (including Commerce, Economics or Public Administration) from a recognized University

OR

Any other qualification acceptable to the Senate of the University of Colombo on the recommendation of the Faculty Board.

AND

Has a good working knowledge of English.

Selection Procedure

- The suitability of the applicants to the programme is assessed using the information provided in the application. All the applicants who do not satisfy the minimum qualifications and post-qualifying work experience at managerial capacity will be rejected.
- The remaining applicants will be called for a written examination in which analytical skill, conceptual skills, knowledge of the business environment and proficiency in English will be evaluated.
- Successful applicants at the written examination will be called for an interview in which the applicants are assessed in terms of their demonstrated management competencies, potential corporate leadership capability, and personal characteristics.
