01. EDUCATIONAL QUALIFICATIONS

(A) Temporary Lecturer:

(1) A Degree in **BBA** with a specialisation in **Business Economics** with First or Second Class (Upper Division) Honours;

OR

(2) A Degree in **BBA** with a specialisation in **Business Economics** with Second Class (Lower Division) Honours;

OR

(3) (a) A Degree in **BBA** with specialisation in **Business Economics** without honours or any other Degree with at least Second Class Honours;

and

(b) (i) A Doctoral Degree in **Business Economics / Economics** or in the relevant field

or

(ii) A Masters Degree in the relevant field obtained after a full-time course of study of at least 24 months duration (or an equivalent part-time course of study) with a research component by way of thesis/dissertation

or

(iii) A full time Masters Degree in the relevant field of a minimum of 18 months duration with at least 60 credits* of which not less than 15 credits* of research by way of thesis/dissertation

*[*One credit considered per course unit/module should be in accordance with the Sri Lanka Qualifications Framework (SLQF)]*

02. SALARY AND OTHER CONDITIONS OF APPOINTMENT:

The appointment will be on time-specific contract for a period of six months or one year, which may be extended at the discretion of the Council of the University of Colombo.
